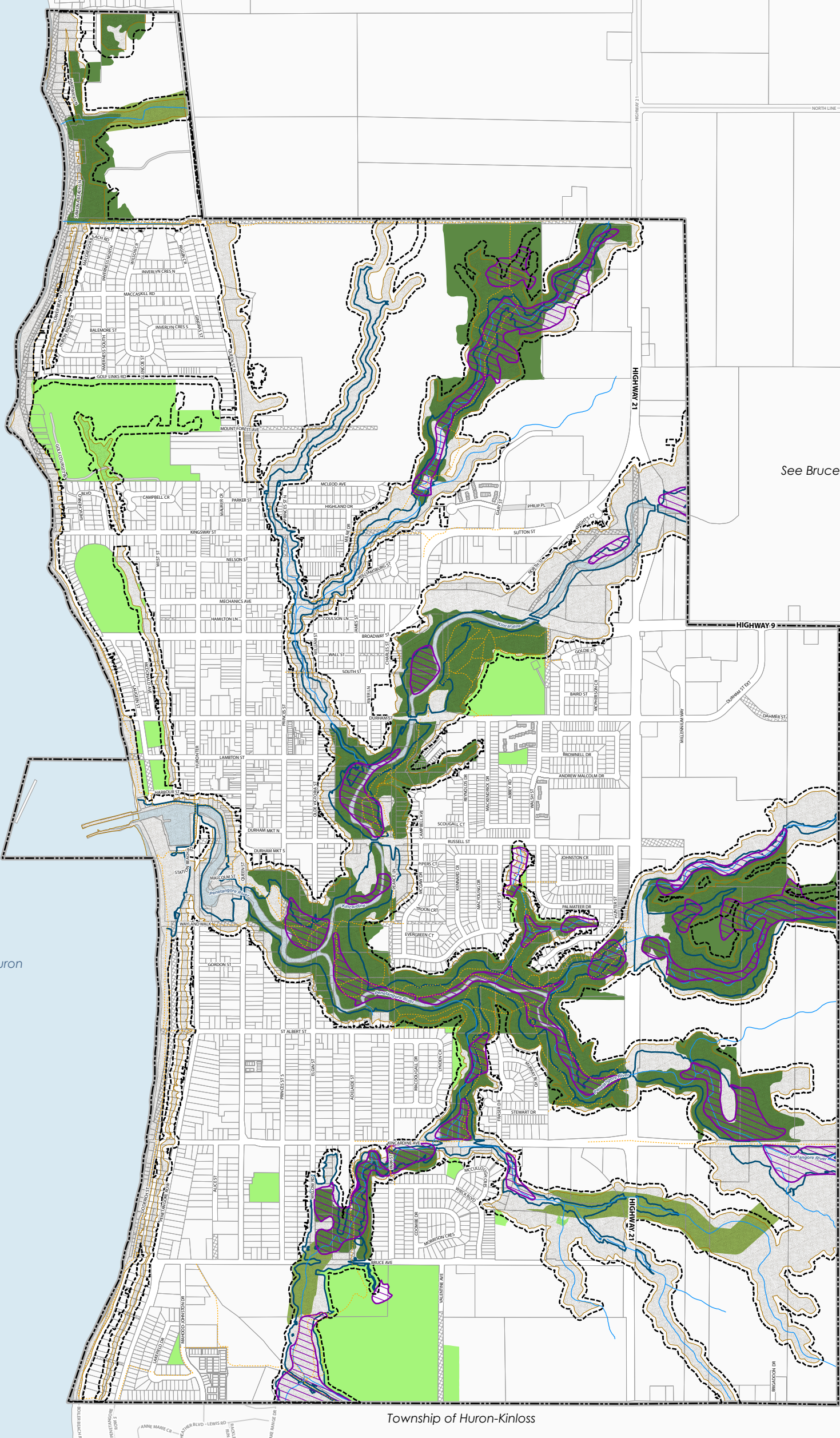
Official Plan Lakeshore Area B Land Use Plan
