**BEING A BY-LAW TO AMEND BY-LAW NO. 2019 - 165;
BEING A BY-LAW TO REGULATE TRAFFIC AND PARKING IN THE
MUNICIPALITY OF KINCARDINE**

WHEREAS the Municipal Act, S.O. 2001, c. 25 as amended, Sections 11(3) and 27(1), gives lower tier municipalities the power to pass by-laws within the sphere of jurisdiction dealing with highways; including parking and traffic;

AND WHEREAS Section 245 (1) of the said Municipal Act, authorizes a municipality to pass by-laws providing that a person who contravenes the by-law is guilty of an offence;

AND WHEREAS the Highway Traffic Act, R.S.O., 1990, c. H.8 and the regulations made thereunder permit the councils of local municipalities to regulate traffic and parking;

AND WHEREAS the Council of The Corporation of the Municipality of Kincardine deems it necessary to amend Schedule “B”, Part IV, Section 3 – No Parking and Schedule “N”, Part XI Intersection Stop Signs, of By-law No. 2019 - 165;

NOW THEREFORE the Council of the Corporation of the Municipality of Kincardine **ENACTS** as follows:

1. THAT Schedule “B”, Part IV, Section 3 – No Parking, of By-law No. 2019 – 165 Traffic and Parking By-law, be amended to include the following:

Highway	Side	From	To	Times/Days	Duration
Huron Terrace	East	Broadway Street	St. Albert Street	Anytime.	December 31, 2021
Penetangore Row	East	St. Albert Street	Bruce Avenue	Anytime.	December 31, 2021

2. That Schedule “N”, Part XI Intersection Stop Signs, of By-law No. 2019 – 165 Traffic and Parking By-law, be amended to include the following:

Highway(s)	Intersecting at	Travelling	Duration
Huron Terrace	Lambton Street	North	December 31, 2021
Huron Terrace	Lambton Street	South	December 31, 2021
Huron Terrace	St. Albert Street	North	December 31, 2021
Huron Terrace	St. Albert Street	South	December 31, 2021

3. That this by-law shall come into full force and effect upon its final passage.
